# Invitation For Bid GSA-079-25

Removed and Replace Exterior Lights for the Village of Sinajana

### Questions and Concerns received from Polyphase System Inc. on September 12, 2025.

- 1. Kindly Provide the technical specification for the existing poles, including
  - 1.1 Material composition,
  - 1.2 Height,
  - 1.3 Top and bottom diameters,
  - 1.4 Wall thickness.
  - 1.5 Rated wind load capacity,
  - 1.6 Foundation details.

This information is necessary to assess the poles' load-bearing capacity and verify whether they can safety support the combined wind load and weight of three (3) 1500W solar-powered LED light fixtures per pole.

#### Response:

- 1.1 Gaulvenized Metal
- 1.2 16 feet High
- 1.3 Top: 2 inches / Bottom: 4 inches diameter
- 1.4 0.125 inches
- 1.5 up to 150mph
- 1.6 Pole secured to concrete foundation.

Yes. These poles can safely support the combined wind load and weight of the requested lights.

- 2. Please provide the technical specifications for the following:
  - 2.1 High bay type light fixture (8" round),
  - 2.2 50w and 1500W Solar-powered LED Light Fixtures, and
  - 2.3 Domestic preference requirements (whether BAA/BABA or not).

#### Response:

- 2.1 High Bay LED Lights: 150W / 100-277 Volts / 18,000 Lumens or higher / 5,000 K Color Temperature / 70CRI or higher
- 2.2 Solar LED Light 1500W and Solar Panel 50W
- 2.3 Solar LED Light 1500W and Solar Panel 50W
- 2.4 This project is not regulated by BAA or BABA requirements.
- 3. Kindly specify the source of funds allocated for this project.
