Questions and Concerns received from Cars Plus, LLC on September 20, 2024.

1. Would you be able to extend required delivery date from 120 Days Upon receipt of purchase order to 365-380 Days? Reason: This would give the sufficient amount of time to produce & Ship vehicles at a high volume of units requested for this bid.
Response: See Amendment #2.

Questions and Concerns received from Monster Auto Corp dba Guam Autospot on September 24, 2024.

1. Hafa adai! If we can provide pickup truck with the specified capabilities and features outlined in the bid, would that be acceptable? For example, a 4-Door 4WD pickup truck equipped with a police pursuit package and a locking tonneau bed cover for adequate storage space.
Response: No, bid specifications will remain unchanged.

Questions and Concerns received from Triple J Enterprises, Inc. on September 26, 2024.

1. We request a one-week extension deadline for the questions and concerns in order to allow additional communication time on the newest 2025-year model pricing and availability with our Police Vehicle Supplier. New 2024 Models are no longer available so 2025 Model pricing and production schedules are in the works.
Response: See Amendment #1.
2. Color: Since the Police SUV's will have Guam's unique GPD graphic designs and stickers, we suggest the exterior color paint specification (Color: P.37 or 42) be changed to the "Industry Standard" of a solid color such as black or white. White would be the most practical color for Guam's extreme heat on the engines and interiors given off by a black or black & white color. White doors & roof alone will not help dissipate the extreme heat on the engines. Should GPD still desire the black color then we suggest a solid black color to avoid expensive wraps or 2-tone paint.
Response: Bid specifications will remain unchanged.
3. We request the delivery time be changed from 120 Days to 210 Days to allow time for at least 28 ea Special Order Police Vehicles to be factory produced, up fitted with Guam specified police lighting and equipment, then shipped to Guam, and prepared for delivery to GPD.
Response: See Amendment #2.

Questions and Concerns received from Triple J Enterprises, Inc. on October 7, 2024.

1. Delivery P4 of 42 - Please amend the delivery requirement from 120 days to 180 Days per factory production availability. Police Vehicles are a factory special order item and there is currently a substantial back log of production due to extremely heavy demand through out the united states.
Response: See Amendment #2.

2. Light Bar Colors: P39 of 42 – Please amend the emergency light colors from Blue / Blue to the industry standard, and factory installed for police patrol cars which is Red/Blue. Factory equipped lighting is red driver’s side and blue passenger side.

Response: Bid specifications will remain the same in accordance with Title 16 of the Guam Code Annotated Chapter 3 §3202(c) which states “All automobiles or motorcycles used or authorized to be used by the Guam Police Department as police vehicles shall be equipped with blue revolving or flashing lights.”
