Invitation for Bid GSA-035-24 Sedan, Mini Vans, and Trucks (Latest Model)

Questions and Concerns received from Monster Auto Corp dba Guam Auto Spot on September 30, 2024.

- 1. We are writing to formally request consideration of the specifications of our Mitsubishi Mirage G4 and Mitsubishi Outlander Sport for the current bid, which specifies a 4-cylinder sedan. While our Mitsubishi Mirage G4 is equipped with a 1.2L MIVEC DOHC 3-cylinder engine, we believe it offers several key benefits that align well with the objections of this bid, particularly in terms of fuel efficiency, cost-effectiveness, and environmental sustainability. Some key advantages include:
 - Exceptional Fuel Economy: The Mirage G4's compact 1.2L engine delivers superior fuel efficiency, which translates into significant long-term savings on fuel costs.
 - Lower Emissions: With a smaller engine, the Mirage G4 contributes to reduced carbon emissions, making it an environmentally friendly option

In addition, we can also propose the Mitsubishi Outlander Sport, a compact SUV equipped with a 4-cylinder engine, which may meet the specified criteria for engine size while providing additional versatility and cargo space. We believe these vehicles meet the spirit of the bid in terms of performance, economy, and environmental considerations, and we kindly request your approval to submit these options for consideration.
