These specifications have been written to describe minimum equipment and performance requirements to be supplied by the equipment manufacturer bidding. Reasonable test may be conducted upon delivery before acceptance.

The successful bidder shall furnish all necessary and desirable information instructions for the proper operation of the equipment.

The subject specifications were drafted to allow for reasonable bid competition, however, needed to be tailored to meet the specific needs of the Guam Police Dept. The minimum requirements specified were established through market research of product availability and capabilities with references and or recommendations from local and off-island dealerships.

Each vehicle shall be new, unused and the current model year production.

Each vehicle shall be supplied with all standard equipment and accessories indicated in manufacturer's published literature/brochure unless specifically deleted as stated in this specification. Optional equipment necessary to meet the requirements of this specification shall be installed.

SPECIFICATIONS:	BIDDING ON / REMARKS:
FUEL EFFICIENCY: The most fuel efficient product available shall be offered to meet the requirements of this bid specification.	
ENGINE: V6 or larger, water cooled, gasoline and an auxiliary engine oil cooler shall be installed as necessary to maintain oil operating temperatures.	
BODY: Cargo Van. 5 doors (including side sliding and rear doors). Extended version van with the overall length up to 20.0 feet and the interior load height/standing height up to 76 inches from floor to ceiling.	
SEATING CAPACITY: Two (2) passengers or greater.	
COLOR: Vehicle body must be white.	
ELECTRICAL SYSTEM: 12 volt, negative ground, with a 200 amp High output Alternator or greater.	
BATTERY: The vehicle battery shall be the heaviest duty type available, compatible with the vehicle charging system and intended for police service. The vehicle battery shall have rundown protection, with manufacturing date not exceeding three (3) months prior to vehicle delivery. Vehicles will not be accepted with batteries exhibiting less than 90% of full charge at time of delivery.	
TRANSMISSION: Heavy duty automatic transmission equipped with auxiliary transmission fluid coolers, if necessary, to maintain oil operating temperatures, and calibrated for police use. Shall be a center or steering column shifter.	
DRIVE TRAIN: (4x4, AWD, FWD, or RWD) with Traction Control.	
SUSPENSION: Heavy duty front and rear suspension with stabilizer bar(s) is required. No less than 6 inches of ground clearance.	
STEERING: The steering shall be power assisted. The power steering system shall be equipped with a fluid cooler, to maintain power steering fluid operating temperatures, if available. A tilting steering wheel is required.	
BRAKES: The vehicle shall be equipped with stability and control. The brakes shall have an anti-lock brake system (ABS).
