Fourteen of 707 Test Positive for COVID-19;
UPDATED: COVID-19 Vaccination and Testing Schedule

Results: Fourteen New Cases of COVID-19

Fourteen (14) new cases of COVID-19 were identified out of **707** tests performed July 20 – 21. **Twelve (12)** cases were identified through contact tracing. To date, there have been a total of **8,500** officially reported cases of COVID-19 with **143** deaths, **59** cases in active isolation, and **8,298** not in active isolation. **The CAR Score is 0.1.**

Operation Liberate Guam update: To date, a total of **94,715** or **78.90%** of adults have received either both doses in the two-dose series (Pfizer-BioNTech and Moderna) or the single-dose series (Johnson & Johnson/Janssen) of the COVID-19 vaccine.

COVID-19 Vaccination Schedule

COVID-19 vaccination clinics continue at the locations and times below. Bring a photo ID. Those due for their second dose are reminded to bring their COVID-19 immunization card. To view the complete schedule of COVID-19 vaccination clinics, visit dphss.guam.gov/vaccinategu. Minors must be accompanied by a parent or legal guardian and provide government-issued identification to validate age. Minor’s birth certificate is acceptable. Parent/legal guardian must have a government-issued ID. Guardians must also present legal guardianship or power-of-attorney document.

COVID-19 community testing continues. No symptoms are needed to qualify for testing. Bring a photo ID. Results available onsite. Testing for travel purposes will **not** be conducted at these community testing sites. Call the DPHSS Northern Region Community Health Center at 635-7525/6 to schedule an appointment for COVID-19 testing for travel. Priority is given to patients under investigation and those traveling for medical purposes. Only four (4) people per vehicle are allowed to be tested.
